

**Complete Event rules**  
**“Questionnaire Competition”**

**I. Introductory provisions, time and place of the Event**

1. This document contains the complete rules of the marketing event titled **“Questionnaire Competition”** (hereinafter as the **“Event”**). The Event is organized by the company **HP TRONIC, s.r.o.**, having its registered office at náměstí Práce 2523, 760 01 Zlín, Company Reg. No.: 60323418, registered in the Commercial Register administered by the Regional Court in Brno, section C, file no. 38954 (hereinafter as the **“Organizer”**).

**II. Event period**

1. The Event will be held from **1. 4. 2022 to 31. 12. 2022 inclusive, or until further notice** (hereinafter as the **“Event Period”**).
2. The Event may be ended earlier subject to the condition set out in sec. VII., par. 2, hereof.

**III. Participation in the Event**

1. The Event is open to any natural person over 18 years of age.
2. To take part in the Event, the participant shall fill in their registration data in the Satisfaction Questionnaire they receive in connection with the provision of services by the Organizer and give their consent to the participation in the Event.
3. It is possible to take part in the Event repeatedly, however only once in a calendar month.
4. To be eligible for participation in the Event, the following data need to be filled out:
  - name,
  - surname,
  - e-mail address,
  - town/city.
5. For participation in the Event, it is necessary to express consent to the Complete Event Rules while filling out the Voucher. The Event rules are available for reference from the Organizer or at **[www.valachy.cz/dotaznik/](http://www.valachy.cz/dotaznik/)**. The participant undertakes to abide by the rules.

**IV. The course of the Event and prizes**

1. Each participant who meets all the conditions set out in par. 3 hereof will be included in the Event.

2. 5 randomly selected participants engaged in the Event will be the winners.
3. Such random selection will be made each month from the participants engaged in the previous month (between the first and last day of the month).
4. Prize shall mean:
  1. 50-minute relaxation massage for 1 person in Wellness Horal, L-Spa or Fyzio Garden,
  2. all-day admission to all Wellness Horal areas for 1 person (no limitation as to the days),
  3. admission to all Wellness Horal areas for 1 person for 4.5 hours (no limitation as to the days),
  4. admission to Wellness Horal thermal pools for 2 persons for 2.5 hours (no limitation as to the days),
  5. admission to Wellness Horal thermal pools for 2 person for 2.5 hours (off season).
6. The prize is not a subject of a purchase contract. Winners do not have any rights arising from defective performance.
7. Prizes may not be exchanged for money and are not intended for re-sale.

#### **V. Exclusion from the Event**

8. Any persons who do not follow the Event rules or breach the Event rules in any way shall be excluded from the Event.
9. The Event shall not apply to employees of the HP TRONIC group.
10. The Event Organizer shall be entitled to exclude any participant who is suspected to have obtained their participation in the Event through fraudulent conduct or conduct contrary to good manners that may influence the Event results. Such Organizer's decision shall be final, without the possibility of appeal.

#### **VI. Personal data protection**

1. The processing of the personal data provided, i.e. name, surname, e-mail address and town/city (hereinafter as the "Personal Data") by the Organizer, being the data controller, for the purposes of evaluating the Event and sending e-mails with information about the Event is a prerequisite for participation in the Event. The Personal Data shall be processed for that purpose until the Event end only. After that, the Personal Data shall be stored for a period of 2 years from the end of the Event for the purposes of inspection, dispute resolution and statistical, technical or other assessment. Subsequently, all data shall be anonymized or deleted.

2. The participant acknowledges that they have a right of access to personal data as well as other rights under Regulation (EU) 2016/679 of the European Parliament and of the Council, mainly the right to rectification of your personal data, right to object, right to request an explanation from the Organizer, right to request elimination of any situation created, mainly by blocking incorrect personal data, rectification, amendment, disposal or erasure thereof. A request for erasure of Personal Data and a request for restriction of processing personal data that are processed for the purposes of evaluating the Event, sending e-mails with information about the Event and sending prizes made before the Event results are announced shall result in excluding the participant from the Event. In case of any doubts as to compliance with rights by the Organizer (data controller), the participant may contact the Organizer, or the Personal Data Protection Authority directly.

## **VII. Final provisions**

1. In connection with this Event, the Organizer shall not have any obligations towards the participants and the Event participants shall not have any entitlements to any other performance by the Organizer other than that specified herein.
2. The Organizer reserves the right to cut the Event short, suspend or end it as well as to amend its rules, also without giving a reason. Should there be a change in the rules and conditions, the Organizer shall inform the Event participants through notice on the Event website.
3. The Organizer shall be entitled to check compliance with all the conditions for participation in the Event, and in the event of a dispute assess and make a final decision on any issue connected with the Event.
